## DESCRIPTION

Join us for seven weekly sessions which will be facilitator-lead discussions about the many ethical decisions interpreters make on the job, and the impact those decisions have on all the stakeholders. Each week of this series participants will apply a different tenet from the RID Code of Professional Conduct (CPC) to an ethical interpreting scenario.

Prior to the scheduled sessions, participants will receive a scenario that includes an ethical dilemma, they will review the situation, prepare their response, citing specific RID CPC Tenets, keeping in mind the RID Ethical Practice Policy and Enforcement Procedures guidelines (EPS), followed by a discussion with peers. The facilitator will guide the group through an in-depth analysis of various decisions the impact those decisions could have on stakeholders, including deaf members, hearing members, and the interpreting profession.

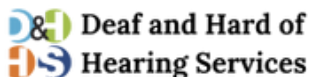
## OBJECTIVES

Participants will be able to:

- Employ critical thinking skills to parse out the ethical dilemmas in each scenario.
- Describe what actions they would take to resolve an ethical dilemma.
- Refer to specific RID CPC Tenets to support their decisions.
- Reflect on their own decisions and respond to feedback from colleagues.
- Formulate two options for resolving ethical dilemmas, using the RID EPS.
