
# COLLECTIVE COMMUNITY HEALTH: DEAF COMMUNITY AND INTERPRETERS WORKING SIDE-BY-SIDE

## DESCRIPTION

This workshop is a two-day event focused on bringing Michigan Deaf and interpreter community members together as a collective to review what it means to work side by side as a team that supports a collective community health with a focus on mental health.

Rosemary and Carla will have a panel showcasing the work of Deaf-hearing interpreting teams. Interpreters will have an opportunity to apply role-space decision making points. Deaf community members will learn how to be part of a collective assertiveness to actively take part in meeting their own health needs, and everyone will have an opportunity to practice Deaf-hearing interpreting teams in mock scenarios. Only by working side-by-side will we discover ways to work toward equity in language and cultural access to healthcare.

#### OBJECTIVES

Participants will be able to:

- Employ three strategies for identifying pre/during/post role-space decision making points in mental health settings when part of a Deaf-hearing team.
- Develop a script for requesting a Deaf Interpreter as a team in a mental health setting.
- Define how the decision latitude continuum concept applies to role-space when the goal is equity in inequitable spaces.
- Describe the benefits of deaf-hearing teams in mental health settings based on perspectives shared from the panel.
- Reflect on the importance of utilizing Deaf-hearing interpreter teams in various interpreting settings.
