

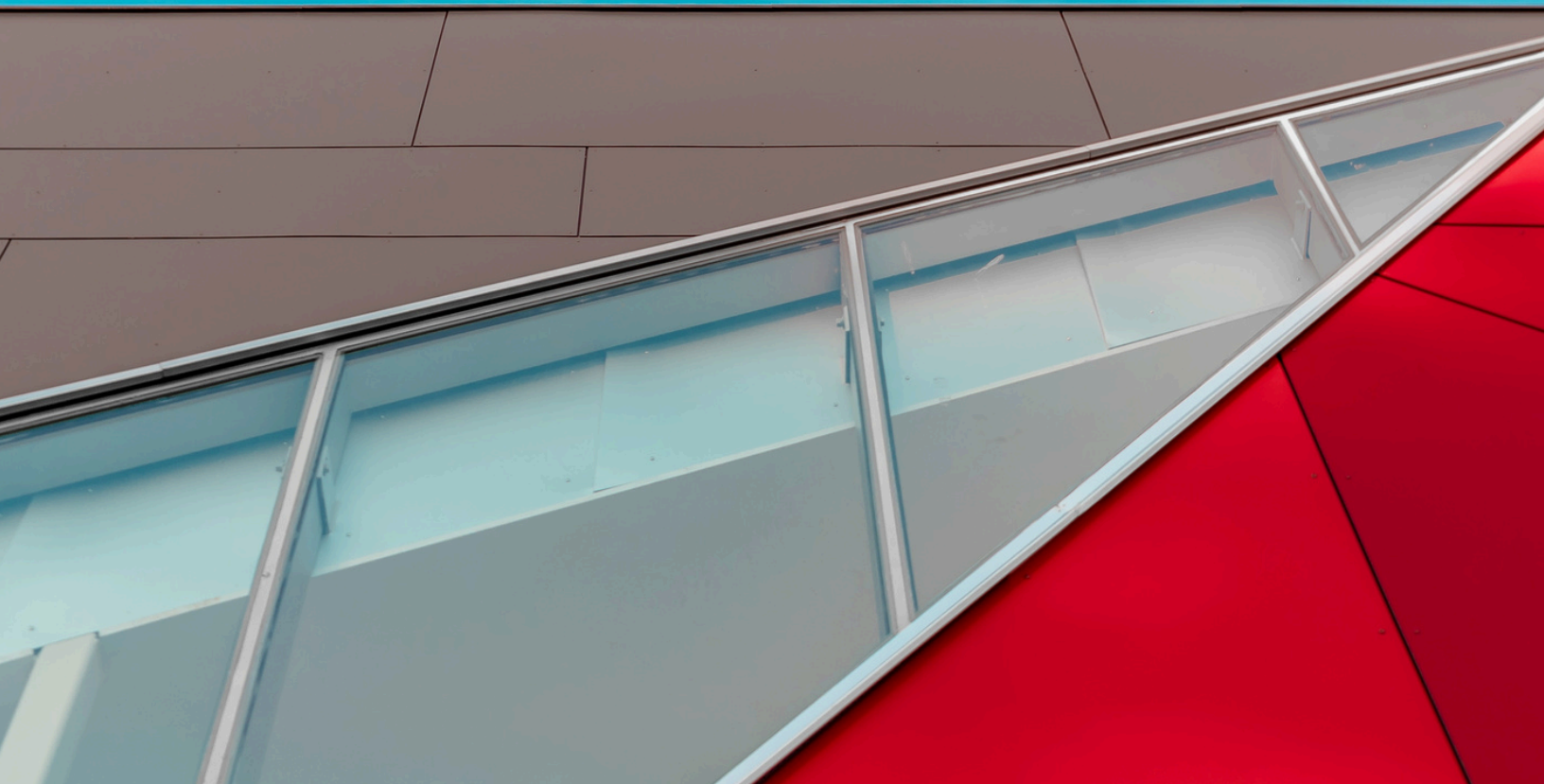

DESCRIPTION

RID launched a robust, revised version of the Ethical Practice System (EPS) policy and enforcement procedures document in June 2023. Did you know RID had an EPS policies and procedures enforcement document from 2006 in place? Were you aware of the re-launch in 2023? Have you read the new document? Do you know where to find it?

Did you know that harmful practices among fellow colleagues or consumers are now your responsibility to report, even if such practices occur outside of the interpreting assignment? The revised EPS is in place and as certified members we have been charged with the duty to hold one another accountable in all settings related to interpreting.

This workshop is an informational session about the revised RID EPS and how it will impact all the stakeholders in our field. Cindy will highlight a few significant changes to the EPS, and point you in the direction of the new policy and procedures enforcement document. This workshop is not for debating ethical dilemmas nor discussing moral decision-making practices, those are for a different workshop. Join colleagues in bringing awareness to these new RID expectations and encouraging each other to be mindful of our responsibility to do no harm.
