

DESCRIPTION

Trauma can take on many shapes and forms, it can be connected to a recent experience or be unrecognized and tied to an event or experience in the distant past. Trauma can impact members of different cultural, socio-economic, language, and age groups in various ways. As an interpreter, are you prepared to recognize and facilitate communication for clients who have experienced trauma?

Join Phelan, Wilma, and Stephanie as they guide us through the concept of trauma and help us examine how trauma is unique to the Deaf community. They will dissect the fundamental principles of trauma-informed care, provide case studies to help us apply our understanding of such care, and teach us how to establish an interpreter self-care plan to better prepare for jobs requiring trauma-informed skills. In addition, they will help participants seek out support and identify resources in their local community. If you interpret in mental health, medical, VRS or community settings you will want to be a part of this amazing, free, in-person training.

OBJECTIVES

At the end of the session, participants will be able to:

- Describe trauma.
- Recognize how trauma manifests in the body and its symptoms.
- Identify traumas specific to the Deaf community.
- Explain the pillars of trauma-informed care.
- Reflect on the survivor's journey in seeking support and resources.
- Apply the pillars of trauma-informed care to the interpreting role using case studies.
- Develop a self-care plan for interpreters and implement what to do before, during, and after an interpreting job.
- Identify local resources to fortify their learning about trauma-informed interpreting.

ABOUT THE PRESENTERS


